#### THE EVIDENCE FOR GOD'S EXISTENCE

#### Introduction

Romans 1:20 tells us that, *God's "eternal power" and "divine nature" can be clearly seen from what he has created, so that mankind is "without excuse"* Yet, many who behold this amazing universe in which we live conclude that the universe came into existence on its own.

Before providing evidence for Gods existence it is important to point out that the arguments used against the existence of God are based on a faulty scientific method used by the proponents of this view for determining the origin of the universe. There are two types of science for studying the universe - *origin science* and *operation science*. Operation science is an *empirical* science based on principles of *observation* and recurring patterns. With operation science no scientific analysis can be made on the basis of a singular event such as the origin of the universe.

Origin science on the other hand, is a *forensic* science that considers past singularities—the *origin* of the universe and life forms. One normally hears of forensic science in law enforcement, where scientists may attempt to reconstruct what happened to cause an unobserved death, for example. Some elements may be repeatable, but not the essential series of events, since the person at the center of those events is dead. Forensic science has its own rules and principles. Using the evidence that remains (such as weapons, injury patterns, blood splatters, and finger prints), the forensic scientist can make a plausible reconstruction of the original event. In a similar way, the origin scientist attempts to reconstruct the origin of the universe and the origin of life.

The difference between *operational science* and *origin science* can be illustrated in the simple example of a windmill. The laws operating during the *running* of a windmill are not sufficient to *produce* that windmill. A windmill functions by purely natural laws of physics pressure, motion, and inertia. Inertia, however, cannot create the design, weld the metal, assemble the wind-powered generator, or adjust the propeller blades. Someone had to come from outside the windmill system, bringing necessary know-how, plans, and manipulation of materials.

The misuse of operational science for proving the origin of the universe has led many to conclude that the universe is self-existent hence there is no creator, no infinite, intelligent being behind the existence of the universe. Origin science is the appropriate science for studying origins because it studies unique, unrepeated events, which origins are by definition. The use of origin science-which takes a forensic approach to the origin of the universe produces evidence in favor of God's existence.

#### THE EVIDENCE FOR GOD'S EXISTENCE

There are three main arguments that demonstrate the existence of God. They are the cosmological argument, the teleological argument, and the moral argument.

#### The Cosmological Argument

This is an argument from creation to a Creator. The term comes from the Greek word, *cosmos*, meaning "universe." The argument itself is dependent on the law of causality that says *every finite thing is caused by something other than itself*. The cosmological argument can be summarized as follows:

- 1. The universe had a beginning. There is a wealth of scientific evidence to support this claim. The second law of thermodynamics states that in a closed, isolated system the amount of usable energy is continually decreasing. Astronomers estimate the age of the Solar System to be 4.5 billion years old. In other words according to science the existence of the universe began 4.5 billion years ago. The important information here is that the universe had a beginning.
- 2. Anything that had a beginning must have been caused by something else.
- 3. Therefore the universe was caused by something else (a Creator).

#### The Moral Argument

The moral argument reasons from a moral law to a Moral Law Giver. The argument can be outlined:

- 1. Moral laws imply a Moral Law Giver.
- 2. There is an objective moral law.
- 3. Therefore there is a Moral Law Giver.

How do we know there is an objective moral law? Terms like "injustice" or "wrong" imply that there is some objective standard of comparison to which the terms refer. Without a moral standard, there would be no moral difference between Adolf Hitler and Mother Theresa. To say Hitler was wrong would merely be an opinion that has no real basis for others to agree with it. If Hitler was wrong by an objective standard, then there must be a standard beyond all of us. If there is such an objective moral law then there must be a Moral Law Giver (God).

Why is it that a child, without being taught, would complain that something wasn't "fair." Fair? Who taught them about fair? Why is it that no one ever has to teach children about fairness, but all parents hear the universal wail of "That's not faa-a-a-a-air!" The concept of fairness is about an internal awareness that there's a certain way that things ought to be. It's not limited to three-year-olds we see the same thing on "Save the Whales" bumper stickers. Why should we save the whales? Because we ought to take care of the world. Why should we take care of the world? Because we just should, that's why. It's the right thing to do. There's that sense of "ought" again.

Certain values can be found in all human cultures, a belief that we act certain ways because they're the right thing to do. Murdering one's own people is wrong, for example. Lying and cheating is wrong. So is stealing. Where did this universal sense of right and wrong come from? If we just evolved from the apes, and there is nothing except space, time, and matter, then from where did this moral sense of right and wrong arise?

The reason all human beings start out with an awareness of right and wrong, the reason we all yearn for justice and fairness is that we are made in the image of God, who is just and right. The reason we feel violated when someone does us wrong is that a moral law has been broken -- and you can't have a moral law without a moral law giver.

**The Teleological Argument** The term "teleological" comes from the Greek word, *telos*, meaning "purpose." This argument reasons from design to an intelligent Designer. It can be stated as follows:

William Paley made a compelling argument years ago that the intricacies of a watch are so clearly engineered that it cannot be the product of nature: a watch demands a watchmaker.

Since every watch has a watchmaker, and since the universe is exceedingly more complex in its operation than a watch, it follows that there must be a Maker of the universe. In brief, the teleological argument reasons from design to an intelligent Designer.

- 1. All designs imply a designer.
- 2. There is great design in the universe.
- 3. Therefore, there must be a Great Designer of the universe.

Probably the greatest evidence of design in creation is DNA, the material of which our genes are made, as well as the genetic material for every living thing on the planet. One of the startling discoveries about DNA is that it is a highly complex informational code, so complex that scientists struggle hard to decipher even the tiniest portions of the various genes in every organism.

DNA conveys intelligent information; in fact, molecular biologists use language terms -- code, translation, transcription -- to describe what it does and how it acts. Information scientists tell us that you can't have a code without a code-maker, so it would seem that DNA is probably the strongest indicator in our world that there is an intelligent Designer behind its existence. An intelligent design demands an intelligent designer. The universe is intelligently designed so of necessity there is an intelligent Designer behind it.

#### The Bible is evidence of God's existence

Every religion has its own holy book, but the Bible is different from all the others. It claims to be the very Word of God, not dropped out of the sky but God-breathed, infused with God's power as He communicated His thoughts and intent through human writers.

The Bible was written over a period of 1500 years, by about forty different writers, on three different continents. They addressed a wide variety of subjects, and yet the individual books of the Bible show a remarkable consistency within themselves. There is a great deal of diversity within the Bible, at the same time displaying an amazing unity. It presents an internally consistent message with one great theme: God's love for man and the great lengths to which He went to demonstrate that love.

A collection of documents that spans so much time and distance could not be marked by this unity unless it was superintended by one Author who was behind it all. The unity of the Bible is evidence of God's existence.

One other aspect of the Bible is probably the greatest evidence that God exists and that He has spoken to us in His holy book: fulfilled prophecy. The Bible contains hundreds of details of history which were written in advance before any of them came to pass. Only a sovereign God, who knows the future and can make it happen, can write prophecy that is accurately and always -- eventually -- fulfilled.

Fulfilled prophecy is just one example of how God shows He is there and He is not silent. How else do we explain the existence of history written in advance?

God exists, and He has spoken.

- He made a "just right" universe that is stamped with clues of its Maker.
- He placed eternity in our hearts, as Ecclesiastes tells us, and all people have a strong moral streak because we are made in the image of a moral God.
- The evidence of design in our bodies, our world and the universe is a signpost pointing to a loving, intelligent Designer behind it all.
- The unity of the Bible and the hundreds of fulfilled prophecies in it show the mind of God behind its creation.

Praise the Lord, pass the serpents in Georgia Reuters/September 11, 2001 By Paul Simao

- Kingston, Ga. -- The congregation was on its feet singing the old Gospel favorite "I Saw The Light" when Rev. Carl Porter put aside his Bible and reached behind the pulpit for the wooden snake box.
- The 56-year-old Georgia preacher slipped his weathered hands inside and, moments later, lifted a 4-foot (1.3 metre) timber rattlesnake into the light. Stroking his deadly cargo, Porter began to hop and strut across the altar.
- "Save me, Jesus," shouted a worshiper, his face streaked with tears. Several others, sensing the presence of the Holy Spirit, uttered strings of indecipherable sounds, a practice known as speaking in tongues.
- Porter, too, was shouting praises and singing, even as the rattler slithered in between his hands, darting its head back and forth in menacing fashion. Several minutes passed before another worshiper stepped forward to receive the snake.
- Returning to the pulpit, the preacher wiped his forehead with a handkerchief and grabbed a mason jar full of strychnine-laced water. He swallowed a mouthful of the clear liquid and smiled.
- "I felt the Spirit move on me," Porter explained hours later as he stood in an empty pew in the Church of the Lord Jesus Christ in Kingston, Ga., one of about 40 churches in the southeastern United States that actively practice snake handling.

# The Evidence of Archaelogy

## New Testament Examples

- 1) Luke 2:1-3---Critics used to argue that there was no census, that Quirinius was not the governor of Syria at the time, and that everyone did not have to return to his ancestral home.
  - Archaelogy has discovered the Romans held censuses every 14 years. An inscription from around 7 B.C. mentions Quirinius as governor. An Egyptian papyrus proves that they had to return to their ancestral homes.
- 2) Acts 14:1-6---Luke implies that Lystra and Derbe are in Lycaonia and Iconium is not. Critics thought Luke was wrong because Cicero indicated Iconium was in Lycaonia.
  - In 1910 a monument was found showing that Iconium was a Phrygian city.
- 3) Romans 16:23---Erastus is mentioned. During the excavations of Corinth in 1929 pavement was found inscribed to Erastus.
- 4) Acts 21:28---Riot breaks out because Paul took a Gentile into the temple. Inscriptions have been found stating: "No foreigner may enter within the barrier which surrounds the temple and enclosure. Anyone caught doing so will be personally responsible for his ensuing death."
- 5) Acts 17:6---Use of the term politarch for the civil authorities in Thessalonica. Word was not found in the classical literature, but later found on 19 inscriptions from that period of time.
- 6) Matthew 28:11-15---A slab of stone was found in Nazareth in 1878, inscribed with a decree from Emperor Claudius (A.D. 41-54) that no graves should be disturbed or bodies extracted or moved. The punishment was death. This was a common decree, but the punishment was not. Could it have been an attempt to quash Christian stories of the resurrection?

### Old Testament Examples

- 1) Sodom and Gomorrah---Evidence of cities in the area where Sodom and Gomorrah would have been.
- 2) David---An inscription from the 9<sup>th</sup> century B.C. refers to both the House of David and the King of Israel. This is the first time any inscription outside the Bible mentions David King of Israel.
- 3) Flood Story---Stories of a flood come from all parts of the world. People as diverse as the Greeks, the Hindus, the Chinese, the Mexicans, the Algonquins, and the Hawaiians have a flood story. One list of Sumerian kings treats the flood story as a historical reference point.
- 4) The Tower of Babel---Archaeology has revealed that Ur-Nammu, king of Ur from about 2044-2007 B.C. supposedly received orders to build a great tower as an act of worship to the moon god. Genesis 11:1 says there was one language on the earth. Philologist Alfredo Trombetti and Max Mueller believe all the languages of the world originated from one language.
- 5) Joseph---In the book, Ancient Orient and Old Testament we learn that Genesis 37:28 gives the correct price for a slave at that time in history. Earlier than this time slaves were cheaper.
- 6) The Assyrians---The discovery of ancient Assyrian tablets confirm every reference in the Old Testament to an Assyrian king. A wall painting from Sargon's palace attests to the battle mentioned in Isaiah 20.
- 7) The Babylonians---Babylonian records indicate that Jehoiachin and his five sons were given a monthly ration and a place to live (II Kings 25:27-30).
- 8) Lachish Letters---Letters found written on pieces of pottery attest to the fact that Lachish and Azekah were the last holdout cities against the Babylonian onslaught (Jeremiah 34:6-7).
